Stated Clerk's Report

Ann Elyse Hicks, Stated Clerk

Items for Information:

- 1. Who are the members of the governing body? The members of the governing body are the thirty-eight teaching elders who are members of Abingdon Presbytery, the ten Commissioned Ruling Elders, and the forty-eight ruling elder commissioners that represent the forty-eight congregations of the Presbytery. For the purpose of this meeting of Presbytery, the members of the Presbytery are signified by either a blue dot or a yellow dot on your name tag that you received when you registered for this meeting of Presbytery. A blue dot on your name tag signifies that you are a minister member of Presbytery, while a yellow dot indicates that you are an elder commissioner. For this meeting of Presbytery, only minister members and elder commissioners have the privilege of voice and vote at this meeting. If you do not have either a blue dot or a yellow dot on your name tag, then you do not have the privilege of voice or vote at this meeting, only those members in attendance with either a blue dot or a yellow dot on their name tag have the privilege of addressing the Presbytery and voting on action items before the governing body.
- 2. If you are wearing an adhesive name tag, this signifies that you are a visitor to this meeting of Presbytery. If the way be clear, then visitors will be permitted to speak and participate in the round table discussions but shall not be allowed to speak in the plenary discussion or vote on issues before the Presbytery.
- 3. Thank you to Pastor Graham Bingham and the entire congregation of Glade Spring Presbyterian Church for hosting us this morning.
- 4. Land acknowledgement rationale: In 2016, the 222nd General Assembly condemned the "Doctrine of Discovery," which allowed colonial powers to claim lands belonging to its inhabitants during the Age of Discovery. Travelers who represented European Christian monarchs could claim the land if those who lived there were not of the Christian faith. Thus, at the 223rd General Assembly in 2018, the PMA Board recommended that each mid-council should begin meetings with an acknowledgement of whose land they are meeting on, and that Indigenous peoples currently living on the land should be invited to bring greetings when possible.

The land that we meet on today in Glade Spring was once home to the Cherokee and Yuchi people.

Note 1. Significant Accounting Policies

Nature of activities

Abingdon Presbytery (AP) is an unincorporated religious association consisting of member Presbyterian Church (U.S.A.) churches in southwest Virginia and member Ministers within its bounds. It is organized for the purpose of nurturing its congregations and pastors and to foster Christian unity among them, and to offer and develop leadership in order that congregations will grow in faith and in numbers. Its mission is one of giving support to the churches and their leaders; providing up-to-date information and material on mission opportunities; evangelism, peacemaking, hunger issues, leadership development, to strengthen the local churches for more effective witness, and to share the ministry of the greater Church in the world.

AP is organized within the Presbyterian Church (U.S.A.) structure as a presbytery in the Synod of the Mid-Atlantic, one of several synods making up the Presbyterian Church (U.S.A.), synods being a religious intermediate governing body responsible for the mission of the Presbyterian Church (U.S.A.), organized on a geographic basis.

AP formed a corporation, Abingdon Presbytery Properties, Inc., in 1980 for the purpose of holding certain investments and accounts on behalf of the member churches. The Virginia Corporation is owned and controlled for reasons of convenience in handling these investment accounts but as of December 31, 2021 Abingdon Presbytery Properties, Inc. is an inactive corporation. AP conducts its operations through its main office located in Wytheville, Virginia.

Support comes primarily from member church and individual donor contributions and per capita assessments (combined as unified mission income), in order to carry out its mission. Certain investment income is derived from its investment holdings to supplement their primary source of revenue.

Revenues from contracts with customers

In May 2014, FASB issued Accounting Standards Update 2014-09 (ASU 2014-09) Revenue from Contracts with Customers (Topic 606) which was effective for annual periods beginning after December 15, 2018, (according to ASU 2015-14 Revenue from Contracts with Customers – Deferral of Effective Date). This guidance requires an entity to recognize revenue to depict the transfer of promised goods and services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods and services. The guidance uses a principles-based approach for determining revenue recognition and eliminates the transaction and industry-specific guidance. The new guidance establishes a five-step approach for the recognition of revenue. AP adopted ASU 2014-09 effective January 1, 2019. AP's revenue is derived primarily from contributions. ASU 2014-09 does not affect how AP recognizes its current revenue sources. As of December 31, 2021 AP still follows this standard, as adopted in 2019.

Note 1. Significant Accounting Policies (Continued)

Clarifying the scope and the accounting guidance for contributions received and contributions

In June 2018, FASB issued ASU 2018-08, Not-for-profit Entities (Topic 958): Clarifying the Scope and the Accounting Guidance for Contributions Received and Contributions Made which was also effective for annual periods beginning after December 15, 2018. The ASU provides a more robust framework for determining whether a transaction should be accounted for as a contribution or as an exchange transaction. The guidance also helps determine whether a contribution is conditional and better distinguishes a donor-imposed condition from a donor-imposed restriction. AP adopted ASU 2018-08 effective January 1, 2019. Implementation of this ASU did not affect any of the revenue recognized by AP for the year ended December 31, 2019. As of December 31, 2021 AP still follows this standard, as adopted in 2019.

New accounting pronouncement

In February 2016, the FASB issued ASU 2016-02 "Leases" (Topic 842). The new standard dramatically changes the manner in which financial statements present operating lease arrangements by lessees (among other things). The new standard requires entities to reflect operating lease obligations on their balance sheets. Income statement treatment of operating leases will be similar to current GAAP in its impact on profit and loss, although operating lease cost will be recognized primarily as amortization and interest expense, rather than rental expense. For AP, the guidance is effective for fiscal years beginning after December 15, 2021 (2022 for calendar year entities). Early adoption is permitted. Management is currently evaluating the effect this new rule will have on the financial statements and has not yet selected the timing of its transition.

Basis of accounting and presentation

The accompanying financial statements are presented on the accrual basis.

AP reports in compliance with FASB ASC 958-205, *Not-for-Profit Entities: Presentation of Financial Statements* which was revised for accounting standards update 2016-14. Information regarding its financial position and activities are grouped according to two classes of net assets: net assets without donor restrictions and net assets with donor restrictions. The two classes of net assets are defined as follows:

- Without donor restrictions Net assets that are not subject to donor-imposed restrictions and may be expended for any purpose in performing the primary objectives of AP. AP's board may designate net assets without restrictions for specific operational purposes from time to time.
- With donor restrictions Net assets subject to stipulations imposed by donors, and/or grantors. Some donor restrictions may be temporary in nature; those restrictions will be met by actions of AP or by the passage of time. Other donor restrictions are perpetual in nature, where by the donor has stipulated the funds be maintained in perpetuity.

NOTES TO FINANCIAL STATEMENTS December 31, 2021

Note 1. Significant Accounting Policies (Continued)

Basis of accounting and presentation (Continued)

FASB ASC 958-205 provides additional guidance on the net asset classification of donor-restricted endowment funds for a nonprofit organization that is subject to an enacted version of the Uniform Prudent Management of Institutional Funds Act of 2006 (UPMIFA). FASB ASC 958-205 requires additional disclosures about an organization's endowment funds (both donor-restricted and board designated endowment funds) and whether or not the organization is subject to UPMIFA.

Fund accounting

In order to ensure observance of limitations and restrictions placed on the use of resources available to the AP, the accounts are maintained in accordance with the principles of fund accounting. Resources for various purposes are classified for accounting and reporting purposes into funds established according to their nature and purposes.

Separate accounts are maintained for each fund; however, in the accompanying financial statements, funds that have similar characteristics have been combined into fund groups. Accordingly, all financial transactions have been recorded and reported by fund group.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could vary from the estimates that were used.

Income tax status

As a charitable and religious organization, AP is exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code.

Cash and cash equivalents

AP considers all highly liquid investments with an original maturity of three months or less to be cash equivalents.

AP maintains cash balances in local financial institutions, which are insured by the Federal Deposit Insurance Corporation (FDIC). From time to time, balances in a particular financial institution may exceed the FDIC limits; however, AP has not experienced any losses on these accounts and feels it is not subject to any credit risk on cash and cash equivalents maintained at their financial institutions.

NOTES TO FINANCIAL STATEMENTS December 31, 2021

Note 1. Significant Accounting Policies (Continued)

Pledge receivables

Pledge receivables are gifts intended for the current year which are not received until the following year. AP recognizes these known gifts (those they expect to receive and therefore no allowance for uncollectable pledges) as pledge receivables at the end of the year in order to recognize revenue in the proper period.

Loans and notes receivable

Loans are carried at the unpaid principal balance following a payment schedule of principal and interest, the outstanding balance is an asset whereas the interest is recognized as income in the period collected. If an amount is deemed uncollectible, the loan is written down to its net realizable value. AP believes all loans are collectible at December 31, 2021.

Investments

Investments are reported at fair value using quoted market prices. Donated investments are recorded at market value at the date of donation and thereafter carried at market value or on the equity method for partnership interests. Interest, dividends, and net realized and unrealized gains and losses are reflected as part of investment income in the Statement of Activities. AP maintains funds in registered mutual funds held by New Covenant Trust Funds, a trust organized with participation from the Presbyterian Church (U.S.A.) Foundation. These funds are not insured by the FDIC.

Revenue recognition, receivables and deferred revenue

Receivables consist primarily of per capita assessments and pledges receivable (which combine to make up unified mission income) that are due in less than one year. AP records per capita assessments as revenue when earned and contributions and gifts as income in the year received. Per capita assessments and pledges receivable intended for the current year but received in a subsequent period are recorded as receivables. Payments received in the current year but intended for the next year are shown as deferred revenue. Management believes all receivables to be fully collectible and accordingly there is no allowance for doubtful accounts.

Assets whose use is limited

Assets whose use is limited consist of assets internally designated by AP for specific use. AP retains control over these assets and may, at its discretion, subsequently use the assets for other purposes. These assets consist of cash and cash equivalents, investments, other property, and certain loans.

If a particular church is formally dissolved by the Presbytery of which it is a member, or has become extinct by reason of the dispersal of its members, the abandonment of its work or any other cause, all such property, both real and personal, present and future, shall be vested in and be the property of AP pursuant to the Constitution of the Presbyterian Church (U.S.A.). Such property is recorded at fair market value at the time AP takes ownership, usually when a member church is no longer an active congregation. Such property can be used in the best interest of the Presbytery (via the New Church Development Fund).

NOTES TO FINANCIAL STATEMENTS December 31, 2021

Note 1. Significant Accounting Policies (Continued)

Assets whose use is limited (Continued)

Loans within this category are stated at their uncollected principal balances according to the negotiated terms of the loan (see Note 2).

Donated services

A number of unpaid volunteers make significant contributions of their time on AP committees and various other projects. AP does not maintain records of volunteer hours. Although these services are necessary to the committees, they are not necessarily provided by volunteers with specialized skills. In addition, they probably would not be purchased if they were not donated as required by FASB ASC 958-205 to be recognized in the financial statements. Accordingly, the value of this labor has not been recorded in the financial statements.

Property and equipment

Property and equipment are capitalized at cost for purchases and at fair market value for donated items. Maintenance and repair items are charged to expense when incurred while major renewals and improvements are capitalized. When property and equipment are sold or otherwise disposed, the asset account and related accumulated depreciation account are relieved, and any gain or loss is included in current year's operations. Depreciation is computed on a straight-line basis over the estimated service lives of the assets.

Estimated useful lives are as follows:

Vehicles 5 years
Equipment 5-7 years
Furniture and fixtures 7 years
Buildings and improvements 15-40 years

AP reviews the carrying value of property, plant, and equipment for impairment whenever events and circumstances indicate that the carrying value of an asset may not be recoverable from the estimated future cash flows expected to result from its use and eventual disposition. In cases where undiscounted expected future cash flows are less than the carrying value, an impairment loss is recognized equal to an amount by which the carrying value exceeds the fair value of assets. The factors considered by management in performing this assessment include current operating results, trends and prospects, the manner in which the property is used, as well as the effects of obsolescence, demand, competition, and other economic factors. Based on this assessment, there was no impairment at December 31, 2021.

Compensated absences

Vacation days are granted each January 1 based on length of employment and/or position held. For non-executive employees, up to one week of vacation may be carried over to the following year as approved by the Executive/Supervisor. The Executive Presbyter is granted 20 days of vacation and 10 days of continuing education each year, but untaken time cannot be carried over to the next year. Accordingly, there can be a liability at year-end recorded for compensated absences if there is approved carry over.

NOTES TO FINANCIAL STATEMENTS December 31, 2021

Note 1. Significant Accounting Policies (Continued)

Classes of net assets

The financial statements report amounts separately by classes of net asset as follows:

Net assets without donor restrictions are those currently available at the discretion of the AP for its operations and general ministry (the General and Operating Fund) and those designated funds with assets whose use is limited.

Net assets with donor restrictions are those contributed with donor stipulations for specific operating purposes or programs, those with time restrictions, or those not currently available for use until commitments regarding their use have been fulfilled.

Net assets without donor restrictions include assets whose use are limited by management and include the following active funds at December 31, 2021:

Reserve Fund – This fund is maintained to have additional funds for the current operating budget for a reserve operating component and other designations. The reserve operation fund's minimum balance to maintain in this fund is 1/4th of the annual budget, or a three (3) months "reserve" or cushion. In November 2017, AP approved other funds to be combined with / moved to this fund, namely the "line items" Unspent Declaration of Intent, Unspent per Capita, the Transfer from Operating Reserve, Designated Funds – Cedar Bluff Manse and the Administrative Commission fund (see below). This fund is shown as "Reserve" in the accompanying financial statements.

Minister's Discretionary Fund – This fund is used for personal emergencies of pastors and DCE's (Directors of Christian Education) and may be in the form of a loan or a grant (gift).

New Church Development Fund – This fund uses the monies and properties of formerly active churches for new church development, grants and/or loans pertaining to new church development including purchase of property, building of structures, and salaries of pastors. The fund is also used to maintain and improve existing Presbytery properties including the properties of churches which have dissolved or come under the direct care of AP. Within this fund there is a special Church Development Discretionary Fund included in this category.

Manse Equity Fund – This fund can be used to support a designated Christian worker (such as a supply pastor or a missionary) and related costs of maintaining a home.

Other Internally Designated Funds – AP occasionally establishes funds apart from the General Fund for internally designated purposes. AP had three internal designations during 2021 titled Preston Benevolence, Wild Goose Community, and the Shepherd's Discretionary Fund. These are included in one category as "other" in the financial statements.

Once the purposes of these funds are concluded the internal designation will be removed and any remaining funds will be returned to the General Fund or, if approved, be designated to other funds.

NOTES TO FINANCIAL STATEMENTS December 31, 2021

Note 1. Significant Accounting Policies (Continued)

Classes of net assets (Continued)

A description of funds classified as being with donor restrictions is as follows:

General Fund – A portion of the general fund is used to show member church non-budgeted designated gifts outstanding at the end of the year, accounted for being with donor restrictions, and therefore a release of restricted funds when paid.

Allison-Ewing Loan Fund – This fund is used for loans to churches for repairs, remodeling, building or purchase of property for church use, supervised by the Committee on Ministry.

Nellie Preston Scholarship Fund – This fund is administered by the Christian Education Committee for up to \$300 per school year for eligible students entering full time Christian work.

Five Cents a Meal Fund – This fund is for the purpose of providing ministry to others in the form of hunger and disaster relief aid through certain designated programs and relief agencies.

Note 2. Notes Receivable

At December 31, 2021, AP held a note receivable from the Love of Jesus Tabernacle after selling property in 2006 to them (acquired from the former Litz Presbyterian Church, Tazewell County). The loan has been classified as an asset in the category "assets whose use is limited" (see Note 3). The note terms provide for monthly payments of \$479 with 8% interest over a 25-year period.

During the year, AP collected principal payments of \$2,666 and \$3,076 in interest income. As of December 31, 2021, all payments were current.

At December 31, 2021, AP held a note receivable from Maranatha Bible Church after selling property in 2019 to them (acquired from the former Mt. Carmel Church of Rose Hill, Virginia). The loan has been classified as an asset in the category "assets whose use is limited" (see Note 3). The note terms provide for quarterly payments of \$1,000 each over 5 years. No interest is charged on the loan. Based on the current low interest rate in the market, imputed interest would be nominal and isn't recorded.

During the year, AP collected principal payments of \$2,666 and \$3,076 in interest income related to the note receivable from Love of Tabernacle and principal payments of \$4,000 related to the note receivable from Maranatha Bible Church, the original balance was \$20,000. As of December 31, 2021, all payments were current.

Investments follow FASB ASC 820, *Fair Value Measurements*, which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority.

AP uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, AP measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Level 3 inputs are to be used only when Level 1 or Level 2 inputs were not available, based on unobservable inputs. Level 3 inputs for the year were based on tax information provided by the limited partnership for the one asset in this category.

The limited partnership does not disclose a specific valuation methodology. The use of different methodologies or assumptions to determine the fair value of the asset could result in a different estimate of fair value at the reporting date, although AP believes the inputs to be appropriate and consistent with other limited partnership participants.

Note 5. Employee Benefit Plans

Note 4.

AP participates in the employment benefit plans of the Board of Pensions of the Presbyterian Church (U.S.A.). The Board of Pensions (the board) administers a comprehensive benefits program for eligible members, which includes employees of AP. The benefit plans (some are optional for participation) cover retirement, death and disability, and health care.

NOTES TO FINANCIAL STATEMENTS December 31, 2021

Note 5. Employee Benefit Plans (Continued)

Pension benefits are under a Defined Benefit Plan, 11% of eligible effective salary (subject to a minimum and a maximum range, currently 25% of prior year's church wide pastor's medium salary). The range and the rate are revised annually and announced as such. The rate is applied to the greater of actual salary or the minimum, a percentage of the pastor's medium salary. Those with more than 20 but less than 35 hours are converted to an equivalent full time 35-hour basis per a formula the board provides. Due to the participation in a national denominational program, details relating explicitly to employees of AP are not available.

There is an optional retirement savings plan offered, a 403(b) Defined Contribution Plan as described in the Internal Revenue Code. This is a plan for those eligible in the pension plan to supplement their retirement and as a primary retirement plan for those not enrolled in the pension plan.

There is also a Death and Disability program that provides long-term disability income protection to members and comprehensive death benefits to survivors, 1% of eligible salary (as described above). There is an optional part for additional coverage beyond the regular plan (fee based on age and coverage options). AP employees can participate in the healthcare program (medical plan and optional dental). The Medical Plan is a typical plan for reimbursement of medical costs after deductibles and co-payments. It's a self-funded plan administered by various Blue Cross Blue Shield organizations; 19% of eligible salary (as described above except 65% is used instead of 25% when applied to base).

During 2021, AP paid \$5,746 in pension benefits for its employees under the plans described above. AP can incur certain housing allowance expenses for its employees classified as ministers (as an ordained minister, qualifying under the definition of the Internal Revenue Code whereby a housing allowance can be designated as part of salary). In 2021, the housing allowances paid totaled \$6,070 for the Stated Clerk, the one employee eligible to receive such payments.

Note 6. Liquidity and Funds Available

AP has checking accounts available to meet budgeted operating expenses in their General Fund. In addition, certain pledges (for its unified mission revenue) are collectible to be used for its budgeted operations. Funds that are internally designated are restricted for specific purposes and are exempted for general use. Donor-restricted funds are also not available for general expenditure.

Note 7. Payroll Protection Program Loan (PPP)

AP obtained a PPP loan administered by the SBA through a local bank on May 11, 2020 in the amount of \$16,703. The loan was established by section 1102 of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) in 2020. According to the terms of the agreement, the amount is subject to partial or full forgiveness depending on the review and approval by the SBA following a recommendation by the participating bank. On April 12, 2021, AP was notified the loan was forgiven in full.

Note 11. Contingent Liabilities and Commitments

AP collects both a Synod and General Assembly per capita assessment from member churches and remits those amounts to the forenamed governing bodies. As of the date of this report, AP has remitted all per capita assessments member churches have paid to AP. From November 13, 2008 through December 31, 2011, AP voted to only pay to the General Assembly and to the Synod the per capita payments that are received from the congregations and to no longer subsidize unpaid per capita to the General Assembly and Synod from the reserve funds of AP. This is due to the fact some member churches have either not paid or have withheld their Synod and General Assembly assessments to AP, as some churches having policy issues with the Presbyterian Church, U.S.A.

Under the Book of Order, AP is required to remit the full Synod and General Assembly amounts even if not entirely collected from member churches. Starting again in 2012, AP remitted the full per capita assessment whether they receive a payment from member churches or not.

Note 11. Contingent Liabilities and Commitments (Continued)

By practice, the Synod and General Assembly have not enforced the un-remitted payment. Because of actual practice, AP has not recognized in these financial statements the un-remitted Synod and General Assembly amounts, contingent upon those governing bodies' decision to collect the amounts member churches have not paid. As of the date of this report, such unremitted amounts total approximately \$11,010 and have not been reflected in these financial statements. This is the same as last year's amount.

AP has certain internally designated funds that represent a future commitment as to the use of those funds. The following is a brief summary of those known material commitments.

• Since 2012, AP has paid rent for office space to a member church in Wytheville, the Wytheville Presbyterian Church. The lease was renewed through 2021 at \$7,500 and is part of the 2021 budget and has been approved for the 2022 budget to remain the same.

Note 12. Subsequent Events

Management has evaluated all activity of AP through May 31, 2023 and concluded that no subsequent events have occurred that would require recognition in the Financial Statements or disclosure in the Notes to the Financial Statements.

Synod of the Mid-Atlantic (SMA) 252nd Assembly Highlights

SACRED LAND ACKNOWLEDGEMENT – Ever since the General Assembly of the Presbyterian Church (USA) renounced the Doctrine of Discovery; councils have been encouraged to acknowledge the land on which meetings are being held. The Mid-Atlantic on previous occasions invited decedants of a Tribal People or current Tribal Leaders to attend the Assembly and provide the land acknowledgement. We were honored to have Commissioner Teresa Harris (SHE), a resident of Harrisonburg in attendance. She shared that the Tribes occupying the Valley in the long period prior to the arrival of English settlement included the Iroquois, Shawnee Nations, Catawba, Cherokee and the Susquehannock. We thank God for this land and the inhabitants who lived on it, cared for it, and nurtured the land long before white settlers arrived.

FIFTY YEARS AFTER the March on Washington DC which is in our boundaries, Presbyterians convened at Massanetta Camp and Conference Center in Harrisonburg, VA, to delve into the state of Black Church

Health and Leadership. The 225th General Assembly of the PCUSA highlighted a concerning statistic: over 80% of Black Churches lacked installed pastors. Further, this Assembly acknowledged that since the 1983 Reunion, Black Congregations had, whether intentionally or unintentionally, lost Vision, Vitality, and Community Connections. Therefore, we recognize that the Synod of the Mid-Atlantic (SMA) consisting of 14-presbyteries, emerged as a response to the dissolution of five all-Black Presbyteries. In essence, the Synod's inception stemmed from the profound pain and loss of community,



self-determination, positions and power and identity for Black Presbyterian Presence, Mission, and Witness in the PCUSA.

FORTY YEARS AFTER the reuniting of the two largest bodies of Presbyterianism in the United States, the



252nd Synod of the Mid-Atlantic Assembly came together. Mid-Atlantic Synod boundaries were the last of the sixteen synods to be established, largely because in doing so, five All Black Governing Bodies would have to agree to being dissolved. The Rev. Dr. Edward Newberry, HR member of Charlotte Presbytery reported on the last meeting of the All-Black Catawba Presbytery which he described as sad and ended in tears. The final meeting would bring to end the rich history of Education and Evangelism. It was the end of the significant heritage and the leadership fountain of a presbytery organized seventeen months after the end of the Civil War. Dr. Newberry's article entitled, "Reflections on Reunion" published in Periscope 3, provides perspective to the gravity and impact of Catawba Presbytery. "The lovely carols of Christmas still


lingered in our ears. But a solemn assembly convened at Memorial Church in Charlotte NC on December 29, 1988. Constituted with prayer, we conducted concluding business of our historic judicatory. One of the significant acts of that last meeting of the presbytery was the ordination of Jerry Lytle Cannon to ministry. As an ironic twist of history or act of providence, this was the ordination of the brother of the Rev Katie G. Cannon, who Catawba Presbytery had ordained as the first Black female minister. There was a reluctant motion to adjourn. Yet with hearts and voices, we thanked God for the blessings of in all our generations. We petitioned God's gracious care as we move into tomorrow. Prayers being ended, the Catawba story was finished, now to be inscribe in the Book of Life." Ed's presentation was illuminating and amazing! His

presentation set the stage for the Assembly to address the historical past, current engagement, and possibilities for the future. Would Commissioners who were part of the 114 individuals present be willing and capable of addressing historical and current harms that created structural racism, vestiges of slavery, issues of poverty and dying Black Churches? We are delighted to report that the 252nd Assembly rose to the occasion! Things that are impossible for humanity to accomplish is the STUFF that God does on the REGULAR! The Assembly dedicated itself to doing the heavy lifting, while at the same time taking care of each other in the face of challenging and difficult conversations. We are grateful to Vice Moderator David Cho, who monitored the room thoroughly ensuring that the Assembly consistently took care of each other!

THE NEXT GENERATION INITIATIVE(NGI) rolled out and was amazing! I have yet to attend an Assembly of

any sort where more than 114 commissioners, presbytery leaders Black church leaders, COM and CPM were locked and engaged to the max! Can I Get a Witness? The initiative was bathed in worship, drumming, preaching, fellowship, table talk conversations, affinity group gathering and times of intense celebration. WOW! Each presenter spoke of its urgency, validity, and willingness to partner in its further development and implementation. What is the NGI? Please visit www.synatlantic.org to review the full proposal. In short, the NGI seeks to address the SHORTAGE of Black Presbyterian Clergy



Leadership for Churches, Mid-Councils, Agencies and beyond. At the same time the NGI is calling Black Presbyterian Churches in the Mid-Atlantic to task for examination, diagnosis and prescribing a way forward that will resort or create Congregational Vitality, Purpose in Vision and Direction, Spiritual Formation and Congregational Wholeness. This synod contains more than one-quarter of the Black Churches in the PCUSA. We have accounted for 124-Black Presbyterian Congregations located in eleven of the synods fourteen presbyteries, namely Baltimore, Charlotte, Coastal Carolina, Eastern Virginia, James, National Capital, New Castle, New Hope, Peaks, Salem, and Western North Carolina. We are grateful to these presbyteries for granting synod permission to contact and gather data (Congregational Snapshots and Presbytery Snapshots) from these churches and the presbyteries. Responses to critical questions about pastoral leadership, post-covid congregational challenges, who occupies the pulpit and administers the Lord's Supper have been collected. The synod is grateful to the 12-Snapshot Facilitators who worked more than 3 weeks to gather the critical information.

RADICAL COLLABORATION – Success, as measured in energy, content, design, participation, and engagement, would not be possible without the input, presence and facilitation of the Rev. Dr. Diane



Moffett, President and Executive Director of the Presbyterian Mission Agency, and Dr. Corey Schlosser-Hall, Deputy Executive Director of Vision and Innovation, PMA. Their team of thirteen highly motivated National Staffers from the PMA, BOP, ASG, and Foundation were present in mind, body, intellect, and spirit. In early May, the Planning Team began collaborating and engaging key partners who were interested in the NGI, and we met every two weeks to share, learn and grow. Representatives from Seminaries, GA Agencies, Presbytery Leaders, Historians, and Persons with Passion gathered religiously. The outcome of these gatherings and listening sessions gave rise to an alignment and a perfect partnership between the National Staff and the Synod of the Mid-Atlantic. Dr. Moffett and Staff were in fact MID-WIVES who were present

and coaching the synod as it gave birth to this critical initiative that will benefit the entire PCUSA. This unique aspect of the collaboration involved Staffers facilitating and recording information for a total of six specifically designed Guided Table Talk Sessions, Affinity Groups and Agencies Listening Engagements. One

poignant question raised during engagement was, "What would the NGI look like ten years from now?" The Mid-Atlantic Region is grateful to the individual contributions made by:

presbyteries to serve synod leaders on committees and commissioners. The Assembly elected and installed the Rev. Dr. Eunil David Cho (AKAP) as Moderator and RE Barry Parks (JAM) as Vice Moderator. David is Professor of Pastoral Care at Boston University and Seminary and Barry is retired and serves as Clerk of Session at Westminster PC in Charlottesville, Va. We hope you will have multiple opportunities to meet and chat with them in person or over zoom. With newly elected leadership, the Assembly paid tribute to Rev. Addie Peterson (EVA) for completing her year in style. Addie now assumes the position of Past Moderator for which the term ends in 2024. In that role, she will serve on the Synod Executive Committee. On behalf of the Assembly a gift of

love was presented to Addie by Moderator Cho. Join us as we lift and keep in prayer those whom God has called to synod leadership for such a time as this. Additional individuals were elected to serve on committees and commissioners accordingly to include TE Mary Speers (BAL) Committee on Representation, Class of 2025 and RE Alice Freeman (ABI), Committee on Representation Class of 2026; TE Teressa Page (CCC), Jubilee Fund Committee, Class of 2026 and RE Leslie Bailey (JAM), Class of 2025; and RE Barbara Yancy (BAL), Nominating Committee, Class of 2026.

ADMINISTRATION COMMITTEE Co-Chairs thanked their members as 80% of the committee are

completing two terms of service at the end of the year. Co-chairs are WD Hasty (PEA) and Felicia Hoyle (SAL), Mariam Dewhurst (NAT), Dorothy Descieux (WNC), Kim Robinson (AKAP), Ed Terry (BAL) and Alice Freeman (ABI). Upon the recommendation from the committee the Assembly approved the following actions: A new Child Protection Policy was approved; Fulltime Synod Staff receive a 3% pay increase for 2024; The 2022 Presbytery Minute Review was approved and the Synod Stated Clerk was instructed to communicate to each presbytery stated clerks with a certifying letter expressing thanks and appreciation for their work, and where appropriate request that all exceptions found in the 2022 Presbytery Minutes Review be address before March 2024 review cycle. It is working thru a task force to partner with the Committee on



Representation to develop an Anti-Racism Policy. This committee said Farwell to five of its veteran members who will complete two terms of service, namely, Dot, WD, Mariam, Ed, and Kim. Well done!

GRANTS COMMITTEE Chair, Tolokun Omokunde (NHO), thanked Elease Wilson (PEA), David Lovelace (NEW), Chip Stapleton (CCC), Brian Harroff (EVA), Becky Stanley (WNC), Teresa Harris (SHE) and Betty Perkins (CHA). \$15,000 of College and Seminary Scholarships were awarded accordingly. <u>Stultz Scholarships</u> were awarded to Isaiah Grady and Kerryn Olivia Lowery each for \$4,000. The <u>Euler Scholarship</u> was awarded to Nenio Pfuzeh in the amount of \$7,000. <u>Small Church Grants</u> awards totaling \$20,000 were given to four churches with each receiving \$5,000, namely, *First Presbyterian Church*,

Staunton (ABI) for HVAC; Good Hope Presbyterian Church (WNC) for Window Replacement; First Presbyterian Church, Jacksonville (CCC) for HVAC; and First Korean Presbyterian Church (AKAP) Air Condition in the Church Manse. Visionary Grants totaling \$5,000 were awarded to Farlington and First



Presbyterian Churches in the amount of \$5,000 to nourishing congregations. Peacemaking Grant was awarded to Voices of Jubilee in the amount of 25,000 to support a Prison Youth Ministry. National Capital received a \$5,000 grant to certify trainers and facilitators. Williamsburg Presbyterian Church was awarded \$5,000 to support a Hunger Program. The Assembly voted to place a \$10,000 cap on requests for Peacemaking Grants. Applications denied included Hillsville PC because it received funding last cycle; Forest Hill PC (Entry Doors) Fund limitation; and Dellebrooke PC was asked to reapply with more specific needs.

FINANCE COMMITTEE Chair, Cherry Peters, was gracious in thanks and praises of her committee members who included Elease Wilson (PEA), Tim Bird (ABI), Carl Wilton (BAL) and Clifford Thomas (NHO). The committee assumed just under 4% decrease in per capita donations from Presbyteries which increases



the draw from reserves to cover loss of per capita and new requirements. Overall increase in income + draw 10.5 %. Areas of expense include a 3% increase for full-time staff salaries, plus concomitant increases to board of pensions, payroll taxes. Impact of the decision earlier this year to increase marketing and grant writing using professional help. 13.6% increase

in cost of two Synod Assemblies in 2024 over BUDGETED amount in 2023. The 2023 actual will be over budget and the effective increase for next year will be more modest. The overall increase in expenses comes in at 9.0%. The committee advised the Executive Committee concerning the synod's capacity to contribute to the Centennial Capital Campaign. The Assembly approved the 2024 Mission and Operating Budget in the amount of \$421,139.91. **Per capita remains at \$1.15 for 2024.**

THE EXECUTIVE COMMITTEE is composed of Moderator Addie Peterson, Steve Scott, Felicia S. Hoyle and WD Hasty, Amanda Pine and Cassandra Thomas, Tolokun Omokunde and Vice Moderator David Cho. Seven recommendations were approved by the Assembly:

- (1) Edits to the Kate B. Reynolds Certification Committee Guidelines.
- (2) Permission was granted to the 252nd Assembly Planning Committee to finalize planning.
- (3) Amanda Pine (EVA) and Cassandra Thomas (CCC) are co-chairs of the Emerging Ideas Committee.
- (4) \$50,000 was approved for Massanetta Springs Centennial Campaign.
- (5) \$50,000 was approved to launch the NGI for Leadership and African American congregations.
- (6) \$25,000 was approved for PDA to assist in responding to the tragic fires in Hawaii.
- (7) \$26,000 was approved in support of Emerging Ideas Committee for 2024 budget.

THE EMERGING YOUNG BLACK PRESBYTERIAN VOICES were hard hitting and astute. The biggest mistake



of the Assembly was to designate only 75 minutes for this segment. It needed a full 2-hours; however, the wisdom of Moderator Addie Peterson extended the time. Facilitated by the Pastor of Memorial Presbyterian Church in Charlotte NC, the Rev. Shavon Starling-Louis guided four other young voices who were seminarians or recently ordained in

the PCUSA. The Late Rev. Dr. Gayraud Wilmore in writings raised gut-retching questions such as, 'Can one be Black and Presbyterian at the same time? Does Reformed Theology allow me to authentically who I am in the White Denomination? When most students entering seminary today are not choosing pastoral ministry as their vocational call, why did you choose to become a pastor or are a pastor? Shavon, who is also Co-Moderator of the PCUSA General Assembly in partnership with Grace Ruth Santana, navigated this and other critical questions. The responses were electrifying. Our region must hear more from these young emerging prophetical voices. They are the church leaders now and church leaders for the future. Big Props to the Rev. Serenitye Taylor and the Rev. Antonio MK Lawrence Jr, and Seminarians Ryan G. Atkinson and Kirk Louis. The Synod Emerging Ideas Committee will continue collaborating with them to establish ongoing, open, and meaningful dialogue with seminarians and recently ordained candidates Ministers of Word and Sacrament. It was great to have five faculty members present from Eastern Mennonite College and Seminary, where Rev. Dr. Dan Ott is Dean of the Seminary to be present for these conversations. You bet there will be an Encore in the coming months!

HEALTH IN PULPITS AND PEWS - Reflecting the mirror side of the NGI was the Assistant Director of

Theology, Formation and Evangelism of the PMA, Rev. Dr. Carlton Johnson. When we talk about healthy Pulpits and Pews, we are talking about people who were formed at one point in a particular way. Spiritual Formation is essential to have both healthy preachers in the pulpits and healthy parishioners in the pews. The lack of Spiritual Formation is one reason congregations are declining and failing to nurture and recruit the Next Generation of Leadership. Spiritual Formation is a life- long, continuing process that takes place in a community of believers. It involves heart, mind, and soul; therefore, it can be every action, experience, or relationship that northers a transformative relationship of trust with God and shapes the way we see and interact with God's world. Spiritual and Faith Formation will come from home and then we can carry it into the streets. Spiritual Formation has to do with *Valuing Life, Creation care, Relationship*,



Community building, Legacy building, Stewardship, and Institution building. Real chance that structural racism, poverty is affecting the people who are sitting in the pews. How are we able to serve folks who are experiencing structural racism, which is different than calling someone the "n' word. Systemic poverty is not just the food pantry, the question is not how you feed them this week but why they have been hungry all year. Intersectional foci (Climate Change, Gender Justice and Heteropatriarchy, Militarism). As we listen and engage the foci, they are larger in AA communities. Why are more young people trading in church for African Spirituality. Participants were asked how the song that he opened with made them feel as if he lined the hymn and sang it in Long Meter, a style that is still used in a number of Black Churches. Just sit in it. Kids are connecting with African Spirituality. I do not have to surrender my culture to be in touch to be with the Divine. Whoever you are, being authentic is what draws you closer to God (with all your flaws). How do we move with an understanding of separating ourselves with who we are to be closer to the divine?

SHIFTING TRENDS - The Assembly benefited significantly from powerful presentations highlighting the



changes occurring in Church and Society. Rev. Dr. Bruce Grady is the Executive Presbyter for New Hope Presbytery. As a lifelong theological educator, he has served Duke Divinity School, Shaw Divinity School as Dean and directed the Orman Center which helps to make connections between the academy, church, and community. Rev. Dr. Tim Cargal is the Associate Director for Ministry Leadership Development for the Office of the General Assembly. Tim's membership is in the National Capital Presbytery where he served as synod commissioner in 1999. This segment



sets the foundation for understanding some of the societal and cultural shifts occurring at the intersection of church and society. The devastation the pandemic has wreaked

havoc among people and organizations has been acutely felt by churches and their leaders. In addition, Baby boomers are greater in number than successors in many churches. Christianity membership is shrinking in the United States. Non-denominational affiliation is the largest denomination. We examined the Presbyterian Church in general and then discussed the Black Presbyterian Church and Congregations. Further, there have been major shifts in Theological Education as articulated by two scholars in this area.



The Rev. Dr. Tim Cargal is the Associate Director for Ministry Leadership Development for the Office of the General Assembly. Tim's membership is in the National Capital Presbytery where he served as synod commissioner in 1999. The Rev. Dr. David Cho is Assistant Professor of Spiritual Care and Counseling and Co-Director of the Center for Practical Theology at Boston University School of Theology. Currently, he also serves as synod Vice Moderator. Each presenter offered ideas and thoughts on who is attending seminary today. What motivates young people to consider theological education? What career fields are young seminarians gravitating to or from? What are the shifting trends in theological education? How are these factors impacting the next generation of African American leaders to preach in the pulpits, lead mid-councils, and

do community organizing? How are seminarians of color navigating theological education? Are seminaries and presbyteries really making space for different kinds of hermeneutics?

STATED CLERK REPORT – Excuses were granted to Commissioners requesting them. AKAP and CHA did

not have a commissioner present for this Assembly, and it was noted. Thanks were extended to the class of 2023, many of which served two consecutive terms on commissions and committees. Commissioners were reminded that they are the connections to each presbytery and because of such, they are responsible for sharing the work of the synod accordingly. Three separate consultations were held since the last assembly and included Synod Grants, Atlantic Korean



American Presbytery and Kate B. Reynolds Fund. The Synod Clerk participates in the Virginia Council of Churches Judicatory leaders Retreat and as member of the Steering Committee and Coordinating Council. All fourteen presbyteries submitted 2022 minutes for review, and we thank each clerk. I am grateful that the Executive Committee granted permission for the 252nd Assembly to focus on and launch the Next Generation Initiative. Presbytery Search Committees currently active include Salem and Eastern Virginia. Presbytery leaders who will retire before the end of 2023 include Liza Hendricks and Barbara Smith. Appreciation was extended to the Assembly Planning Committee. Synod Staff has added a contract Communication Coordinator who is doing a superb job. The Synod Permanent Judicial Commission has one remedial complaint before it. The Omnibus Motion was approved which included the minutes from

the 251st Synod Assembly, Committee on Representation Report, Kate B Reynolds Minutes and Guideline changes.

CENTER FOR REPAIR OF HISTORICAL HARMS featured the Rev. Anthony Jermaine-Ross Allam, director in full




blaze and armor. He blessed us with information from the office, but more than that, he shared how that information can apply to the Synod. He was a sharer of the Good News that Repair and Reparations are common sense for the common good. Jermaine was ordained as minister of Word and sacrament by the Presbytery of the Twin Cities in 2013 where he began ordained ministry as executive director of 21st Century Academy at Kwanzaa Community Church PC(USA) in North Minneapolis—renamed Liberty Community Church—and, later, Associate Pastor for Social Justice at Oak Grove Presbyterian Church. In addition to serving as the Center for Repair's first director, Jermaine is a PhD candidate in Social Ethics at Union Theological Seminary in Manhattan where he is completing a book tentatively titled "Trammeled by the Bonds of Union: Social Ecology of anti-Black Violence and Impunity after Emancipation." Jermaine is also a proud theology co-lead volunteer with Restorative Actions—an economic equity initiative born from the intersection of theology, justice, and economics based at the

Synod of Lakes and Prairies. This segment will introduce and help make a deeper connection to the 1983 Denomination Reunion and how the Black Presence was weakened, voices eradicated, and relationships eroded. Rev. Ross-Allam raised questions for consideration such as: Was the agency of Black Church Leadership intentionally or unintentionally rendered a slow death blow? What did the Black Church lose in the process and what might be gained because of it? What ought to be the White Presbyterians response to this? What did Dr. Gayraud S. Wilmore predict about Black Presbyterianism in Black and

Presbyterians the Heritage and the Hope? He was laser focused on helping the Assembly to understand the difference between Repair and Reparations.

SOUNDS OF THE DRUMS – The Assembly kicked off, throughout, and concluded its activities with the powerful and rhematic sounds of African Drumming led by Commissioner Tolunkun Omukunde, Alonzo Johnson (PMA) and Keenan Rodgers (BOP). These sounds

He is also the convener of the "Educate A Child, Transform the World initiative. Alonzo has more than 25 years of experience specializing in urban, youth, education, creative arts, antiracism, and social justice ministries. What better way to end four days of inquiry, presentations, table talks, development of strategies and good fellowship than with a Celebration of Worship? Dr. Johnson utilized powerfully charged illustrations that enabled his sermon to be seen and heard. He projected a picture of the late and great soul musical performer, James Brown, holding an infant and



later pointed out that he was the infant being held by James Brown. This was a vivid reminder that one never knows in whose presence of greatness one might find her or himself. The sermon accentuated and raised the level of responsibility as new officers were installed. The Assembly recognized Synod

Commissioners whose terms will end this year and thanked them for years of faithful service to Christ Church in the Mid-Atlantic Region.

RAMBLING THOUGHTS: Several Gospel accounts describe a landowner planning a wedding feast in which many were invited, but for various reasons chose not to attend. He then ordered his servants to go out onto the highways and byways to invite those from the margins. So, they did! The Assembly Planning Team was intentional in inviting its fourteen presbyteries to commit to sending individuals who occupy the following spaces with their presbyteries or churches: Presbytery Executive, Stated Clerk, Representatives from the Committee on Ministry and the Committee on Preparation, three to five Black Church Leaders and its two Synod Commissioners. Further, we invited various agencies from the General Assembly who showed up in large numbers. We are grateful to all who made it a priority to attend and were fully present for the entire Assembly to help launch the Next Generation Initiative. Might God strengthen the ties between the Presbyterian Churches, Presbyteries, Synod and the General Assembly. After all, we are a connectional church!

Items for Information:

The committee has met monthly and we have been working with several churches in our Presbytery who are in transition as well as those who are working on Mission Statements. We have had updates on churches that are doing new things, in particular with the Ukraine Refugee effort.

Faith Statement of Ted Grant

I believe in the triune God as revealed in the Scriptures of the Old and New Testaments: Father, Son, and Holy Spirit. I believe that the Scriptures are the written Word of God, and that God cannot be truly known apart from them. The Word teaches us what we are to believe and what to do and not to do.

I acknowledge myself to be a sinner, violating God's Laws in things I do and in things I fail to do. As a sinner, I deserve His condemnation and eternal damnation. Only through faith in Jesus Christ as my Lord and Savior do I have hope of salvation from the punishment for my sins. I believe that He paid the price for my sin on the cross so that my sins are pardoned, and that God remembers them no more so that I may have eternal life. Because Christ was raised to new life from death, through His grace I have the sure and certain hope that I will be raised in my turn. Truly nothing can separate us from the love of God in Christ Jesus.

I believe in the presence and activity of God in the Sacraments of Baptism and the Lord's Supper. In Baptism, our sins are washed away and we are engrafted into the body of Christ, the Church. In the Lord's Supper, Christ is truly present in the bread and wine, and by faith we are spiritually fed and strengthened by Him.

I believe in the One Holy, Catholic, and Apostolic Church, of which the Presbyterian Church is one branch. While I have worshipped and served in other branches of the True Church and have my disagreements with some of the things the Presbyterian Church does, I am a Presbyterian by the conviction that it is where God wants me to be. My faith has been nurtured and strengthened by both other Christians and by my personal experiences of God's presence and care. Truly God is gracious and good to me, a sinner.

A Brief Biography of Ted Grant

I was born on Palm Sunday, April 2, 1950, at Georgetown University Hospital, where my father was completing his Medical degree. I was baptized in the Presbyterian Church in Mount Vernon, Washington state, my parents' hometown. Following a number of moves, in 1958 we moved to Staunton, where my father had received an offer he couldn't refuse.

During my senior year in high school, I got what I wanted – an appointment to the Naval Academy. I was crushed when, due to my honesty, I failed the vision test and lost my appointment. In retrospect, it was perhaps the best thing that ever happened to me.

I entered UVA in 1968. Two years later, while working at Camp Massanetta (the Synod's facility), I met a wonderful girl. Thirty days later, I proposed to her. Two years later, we were married. During our engagement, I realized that I had been asking the wrong question of "what do I want to do with my life?" When I started asking God what He wanted me to do, I began to experience the call to the ministry.

I finished my degree at Mary Washington College in 1975 and entered Union Theological Seminary under the care of Shenandoah Presbytery. My third year, I served as a student pastor at a two-church field in the mountains of West Virginia. After I graduated

in 1979, the y called me as Pastor, and I was ordained by Greenbrier Presbytery of the PCUS. That call ended due to our marital difficulties, including separation.

We managed to work out our difficulties, and in 1985, I received a call to a two-church field below Hampden Sydney. In 1991, I accepted a call to a church in Columbus, Ohio. That ended after nine years. In 2001, I was called to the church in Sherrills Ford, North Carolina. That ended after ten years.

From 2013 until the end of June 2023, I served as stated supply to a small church in Rutherford County, NC. I would drive over on Sunday and return on Tuesday, having done the worship service, visitation, Bible Study, and meetings. After two years there, I recommended to the Session that they begin a search for a new pastor. Unfortunately, that didn't happen until three years ago. Their search was fruitless, and last year the Presbytery recommended that they cease searching.

Virginia and I have been married now for 51 years. We had three daughters, only one of whom is now still alive. Our middle daughter was killed on October 15, 2016. The hardest thing I have ever had to do was to call her daughter at college and tell her that her mother was dead. Our youngest daughter died on Nov. 12, 2022, from the consequences of her alcoholism.

I can honestly say that Virginia loves Jesus more than she loves me, and that's the way it should be.

Faith Journey of Graham Michael Bingham

Graham was born in Durban, South Africa and was baptized as an infant in the Manning Road Methodist Church. In the first grade Graham's parents moved to the former British colonies of Southern and then Northern Rhodesia where Graham was educated under the British educational system. All the children attended the Methodist Church every Sunday because father insisted, and no excuses were allowed.

Every year Graham received gift Bibles for perfect Sunday school attendance and discovered that church was a wonderful place to meet friends and enjoy the activities of the youth group. Later while in High School Graham was confirmed in the Methodist Church but admits to being only a nominal Christian.

Graham became a believer in the Lord Jesus Christ while reading a *Gideon Bible* in an Army Hospital during military service. At this conversion experience Graham felt called of God to be a minister of the Gospel of Christ.

Graham served in the Seventh-day Adventist Church for 23 years as evangelist, senior pastor, editor, Christian Education Director, and Associate Director in the Department of Church Ministries at the Adventist world headquarters.

Graham's introduction to Reformed Theology occurred while studying for the ministry. One of the requirements in homiletics was to study a great preacher of the past and Charles Haddon Spurgeon was selected. Spurgeon was a strong Calvinist and became Graham's first exposure to the doctrines of grace.

From here on Graham entered a lifetime study of Reformed Theology beginning with *The Institutes of the Christian Religion*, followed by numerous other Reformed Systematic Theologians including the writings of the Puritan's in England. Coincidently all Graham's favorite preachers were associated with the Reformed faith—George Whitefield, Charles Spurgeon, D. Martyn Lloyd-Jones, and Clarence McCartney.

It was a long and difficult theological struggle moving from Adventism to the Reformed faith involving many personal and intellectual struggles. Graduate studies at theological institutions outside of the Adventist circle helped Graham to see that there were doctrines in the Seventh-day Adventist Church that were not in line with the historical Christian faith.

The final move to the Reformed faith came when Graham and Mary (spouse), became members at First Presbyterian Church in Vero Beach, Florida. In January 2014, Sr, pastor Dr. Timothy Womack, invited Graham to join the staff at First Presbyterian as the minister of visitation and congregational care. Under Dr. Womack's mentorship, Graham continued to grow in the understanding of Presbyterian doctrine and polity.

On August 1, 2019, the Westminster Presbyterian Church in Vero Beach, Florida invited Graham to serve as their interim pastor. At the next presbytery meeting on December 3, 2019, Graham answered in the affirmative the constitutional questions (W-4.0403), and after a prayer the Moderator declared Graham a member of the Central Florida Presbytery and Minister of the Word and Sacrament in the Presbyterian Church (USA).

Statement of Faith for Graham M. Bingham

The Scriptures, both the Old and the New Testament is God's Word, inspired by the Holy Spirit but written in human language. It is a revelation of God's truth and is authoritative for the church in all matters of faith and practice.

The Book of Confessions is a reliable and trustworthy historical context for understanding Reformed Theology and interpreting the Bible.

There is one God, who exists eternally in three distinct persons the Father, the Son, and the Holy Spirit. The Christian faith is a trinitarian faith where all three persons of the Godhead are equal in power and authority.

At creation God created all human beings in His image. God's image in human beings was marred by humanity's rebellion and sin and brought about separation between humanity and God. Because of Original Sin all human beings are born sinful and cannot save themselves from God's condemnation and judgement.

Salvation is the work of God alone as He sovereignly chooses those, He calls to Himself. God's election is not based on individual merit or the foreseen faith of individuals but on His grace alone.

Jesus Christ is the eternal Son of God, who through His perfect life, sacrificial death and resurrection atoned for the sins of all those who believe in Him for salvation. Jesus Christ is fully God and fully Man.

The Holy Spirit is the presence of God with us who dwells within every child of God and empowers them to trust and follow Him. The Spirit gives gifts for ministry to every Christian believer and through the sanctifying work of the Holy Spirit, Christians are renewed day by day into the image of God.

The Lord Jesus Christ will return one day personally and visibly to judge all humankind and receive His people to Himself.

God calls people into community with Himself. It happened first with Israel and later as the church. The church is Christ's body on earth where the people of God fellowship, worship, serve, and live for the glory of God in all aspects of their lives.

There are two sacraments instituted by Jesus Christ, baptism, and the Lord's Supper. Baptism is the sacrament signifying the baptized person's union with Christ. Baptism points to a once-and-for-all initiation into the church. The Lord's Supper is a continuing sacrament of communion whereby Christians proclaim their unity and communion with Christ till He comes again. The sacraments, along with the preaching of God's word, are means of grace through which God offers Christ to people.

We do work not so much as a committee, rather as a team and all participate, and all contribute, and all are involved. We would be more than happy to share the dynamics our team uses to be faithful, have some fellowship and fun together, while in the end trying to be effective in making our Presbytery as good as it can be, to the glory of God. Amen.

PRESBYTERIAN WOMEN'S REPORT

By the grace of God, the Women of Abingdon Presbytery continue to work toward and celebrate the pursuit of justice, peace, equity, leadership, charity, Bible study, and spiritual growth.

The Abingdon PW Coordinating Team met at Glade Spring Presbyterian Church on August 19,2023, primarily to make plans for the upcoming Abingdon PW Fall Gathering. Alice Freeman indicated that Glade Spring PC would be willing to host the Gathering. Flyers advertising the Gathering were distributed through Abingdon PW and SMA PW email, USPS, and *Messages from the Mountaintop*, the weekly Abingdon Presbytery online newsletter.

The **Annual Fall Gathering** of Abingdon PW was held at **Glade Spring Presbyterian Church fellowship hall** on Saturday, October 7, 2023. Nine churches were represented with 22 women in attendance. The Rev. Ann Aichinger, pastor of Central Presbyterian Church in Bristol, Virginia, provided guitar music and led songs for the Gathering. The Rev. Ann Elyse Hicks, Abingdon Presbytery Leader, installed the following Abingdon PW officers for the 2023-2025 term: Moderator/Resources, Carol Propst; Secretary, Nicole Reasor; Treasurer, Peggy Slate; Assistant to the Treasurer, Kathy Crotts; Missions/Justice & Peace Chair, Elaine Alderman; Search Chair, Bettie Galliher; Communications Co-Chairs, Alice Freeman and Beth Patterson. The positions of Historian and Spiritual Nurture are currently vacant. The focus of the Fall Gathering was "The Mind/Body/Spirit Connection." Terri Henry of Fairview PC led an interactive lesson on liturgical dance. Carol Propst of Walnut Grove PC continued the theme with a T'ai Chi introduction and a brief presentation on relaxing/finding one's spiritual center with labyrinths. The Rev. Ann Elyse Hicks gave a fascinating and inspiring keynote address/slide presentation on her recent mission trip to Kenya with other members of Abingdon Presbytery. An offering of \$382.00 was collected to be used toward Abingdon PW operations and projects.
